35th Annual FCBA Charity Auction to be held on October 23

The Young Lawyers Committee of the Federal Communications Bar Association (FCBA) and the FCBA Foundation are proud to host the 35th Annual Charity Auction on **Wednesday, October 23, 2024 from 6:30 to 10:00 p.m. EDT** at The Hamilton Live in downtown Washington, DC. Over the past 34 years, our annual charity auction has raised more than \$2 million for philanthropic organizations in the DC metro area. The FCBA is delighted to collect proceeds from this year's Charity Auction and raise awareness to benefit two amazing, local non-profit organizations – **The Washington Jesuit Academy** and the **FCBA Foundation**.

The Washington Jesuit Academy (“WJA”) strives to break the cycle of poverty by offering a rigorous, comprehensive, and tuition-free education to fourth through eighth-grade boys from underserved DC metro communities. In addition to traditional academic programming, the school encourages student participation in

extracurricular activities, serves three nutritious meals a day, assists students with homework completion, and provides counseling services. The Academy also prepares students, parents, and guardians for future educational aspirations after graduation through its High School Placement Program. This program provides information on local high schools, assists with

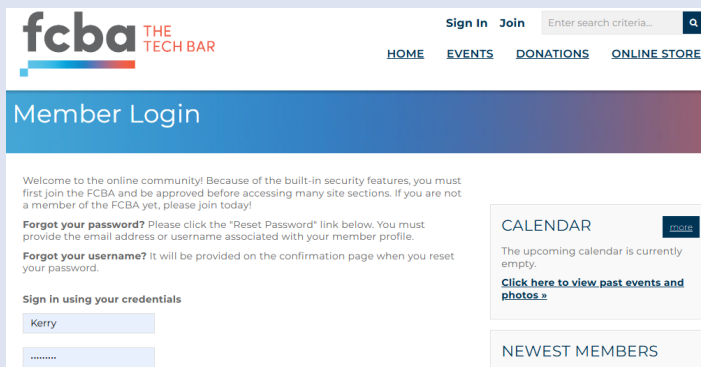

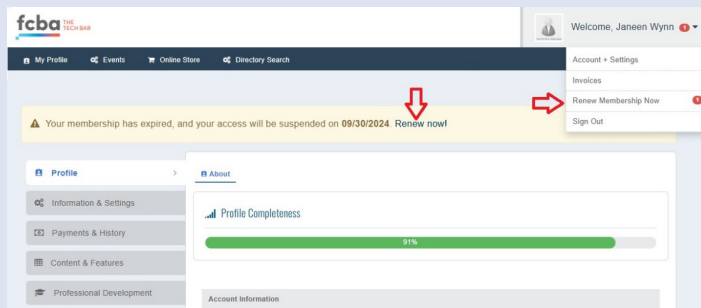

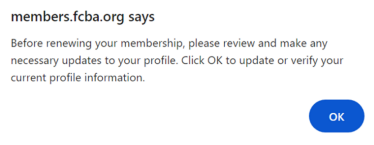

If you are mailing a check, you **MUST** include the printed invoice with your check and mail both to the address on the order.

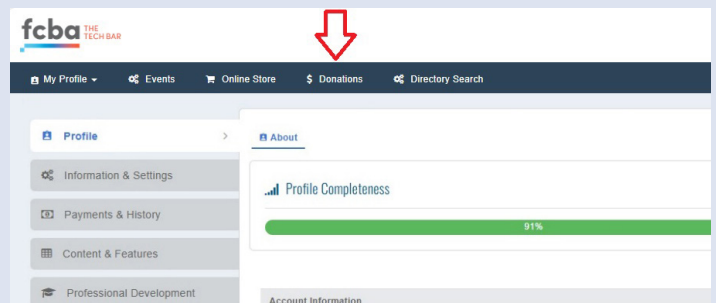
TO PAY FOR A GROUP OF RENEWALS AT ONE TIME

Some firms and companies prefer to pay for a group of membership renewals at one time with one payment. There are two methods to do this:

1. We ask that the firm or company email us a list of renewing members, each person's membership category (e.g., Private Sector) and the associated fee (e.g., \$x / member for Private Sector), and then mail the check to us. For more information or if your firm or company would prefer to pay by ACH, please contact Wendy Parish at wendy@fcba.org.
2. Alternatively, each individual member can log in, process their renewal, and select the Check/Money Order payment type. After that, they should print out the invoice and submit for payment through their internal channels. The firm or company should then mail us all of the invoices at one time, along with the check.

application processes, and helps families and guardians complete financial aid filings. By assisting students in finding the right high school, the Academy helps to ensure students continue to excel beyond middle school. The impact of the Alumni of the Washington Jesuit Academy is evident: 99% of its alumni graduate from high school, and 90% go on to college, trade school, or enter the workforce. WJA encourages inclusivity of all religions and appreciates the fact that most of its students are not Catholic. It seeks to nurture students to grow in their respective beliefs and foster a learning community that extends beyond the traditional school day.

Supporting the FCBA Charity Auction will enable the Academy to serve more students through tuition awards

or through the construction of a new classroom. By participating in this year's auction, you will help further the WJA's mission to provide essential educational, social, emotional, and financial support to local students. Additionally, our donation to WJA will be matched by an anonymous donor, expanding the impact of your contribution.

Participation in the Auction will also support the FCBA Foundation's annual scholarship program. Auction proceeds will be used to provide financial assistance and laptop computers to DC public high school students, helping them thrive in college. 2023-2024 FCBA Foundation Annual Report

This Annual Report summarizes the activities of the Federal Communications Bar Association (FCBA) Foundation during the recently completed 2023-2024 fiscal year.

OVERVIEW

The FCBA Foundation, celebrating 33 years, is a charitable organization working in furtherance of the goals set out in its Mission Statement:

1. To support worthwhile communications-related and educational projects and other community service projects, particularly those directed towards children and students, through financial contributions and volunteer services provided by Foundation members and others.
2. To foster greater public awareness and understanding of the development of communications technology, resources, and law.

This year, the Foundation continued its longstanding support of the following programs:

- Granting four-year college scholarships to Washington, DC high school students.
- Granting one-year scholarships to current law school students who demonstrate an interest in communications law, technology, and public service;
- Granting summer work stipends to law school students serving as interns in communications-related public service jobs.

The Foundation's success is a direct result of the generous financial support of individual FCBA members and their employers, the Foundation Board of

Trustees' time and dedication, the FCBA staff's commitment and contributions, as well as the time, talents, and energy that FCBA members bring to the Foundation's activities.

GOVERNANCE

The Foundation is governed by a Board of Trustees, comprised of individuals elected by the FCBA membership to three-year terms.

This year's Trustees were: **Avonne Bell (Co-Chair)**, **Karen Sprung (Co-Chair)**, **Rachel Wolkowitz (Treasurer)**, **Danielle Thumann (Deputy Treasurer)**, **Van Bloys (Secretary)**, **Rizwan Chowdhry (Deputy Secretary)**, **Angela Ball**, **Kayla Gardner**, **David Grossman**, **Angela Kung**, **Dr. Nicol Turner Lee**, and **Brenda Villanueva**. **Barry Ohlson** served as the FCBA Executive Committee's liaison to the Foundation Board of Trustees.

As of June 30, 2024, four Trustees completed their three-year terms on the Foundation Board: **Avonne Bell**, **Rizwan Chowdhry**, **Brenda Villanueva**, and **Rachel Wolkowitz**. Four new members have been elected to serve three-year terms as Trustees, effective July 1, 2024: **Jacqueline Clary**, **Angela M. DeMahy**, **Crystal Evans**, and **Kristine Hackman**.

Many of the Foundation's activities, including the scholarship and internships programs, community service activities, and critical fundraising events, were jointly led by Trustees and member volunteers. The Board of Trustees is grateful for the broad participation of FCBA members in Foundation programs, and especially for the leadership roles assumed by members beyond the elected board. That extra measure of time and dedication was essential to the success of our programs.

The FCBA's Executive Director **Kerry Loughney**, Senior Manager of Programs **Janeen Wynn**, Bookkeeper **Wendy Parish**, and Member Services Administrator **Elina Gross** also provided invaluable support to the Foundation.

COLLEGE SCHOLARSHIP PROGRAM

Under the leadership of the Foundation's college scholarship committee, **Van Bloys**, **Rizwan Chowdhry**, **Dr. Nicol Turner Lee**, and **Karen Sprung**, the Foundation reviewed applications from high school students of diverse backgrounds with an interest in communications-related fields, including media, journalism, technology, engineering, or law. Our scholarship recipients this year came from 16 local public high schools: Ballou, Basis DC, Bell Multicultural, Benjamin Banneker, Capital City, Cardozo Education Campus, Cesar Chavez, Duke Ellington, E.L. Haynes, Eastern, H.D. Woodson, IDEA, Jackson-Reed, McKinley Technology, School Without Walls, and Washington Latin. All 26 of the recipients will be provided with new laptop computers.

Funding for college scholarships that was not provided by the above donors was provided from the Foundation's general funds, which reflects generous individual contributions from FCBA members and their employers.

INTERNSHIP STIPEND PROGRAM

Under the leadership of the Foundation's internship committee, **Kayla Gardner, David Grossman, Brenda Villanueva,** and **Rachel Wolkowitz**, the Foundation reviewed applications from students at law schools across the country. The Foundation awarded stipends ranging from \$500 to \$5,000 to 12 students who have accepted public service positions for the summer.

LAW SCHOOL SCHOLARSHIP PROGRAM

The Foundation's law school scholarship committee, **Angela Ball, Avonne Bell, Angela Kung,** and **Danielle Thumann**, led the efforts to review applications from current students at law schools across the country who demonstrated merit and need, as well as an interest in communications law and technology and public service. We received applications from students at schools across the country and awarded a total of \$20,000 in scholarships to six law school students.

2023 FCBA FOUNDATION CHARITY AUCTION

Anisa Green

Anyone who has been active with the FCBA Foundation over the last few years or anyone who has attended the Annual Seminar or last few FCBA Spring Receptions hosted at AT&T's Washington DC offices likely knows Anisa Green. Anisa has dual roles within AT&T as a Director within the External & Legislative Affairs Federal Regulatory team and as the Chief of Staff for AT&T's Executive Vice President. She has a wide-ranging portfolio and plainly enjoys what she does. I was delighted to have some time with Anisa this month to hear more about what she does, how she came to these roles and made them her own and of course, to hear her advice to younger communications professionals.



Q: What attracted you to the field of communications?

A: Interestingly enough – I fell into this field. I knew I wanted to be a teacher and use a law degree to help those who could not help themselves. But I wasn't necessarily focused on technology, media and telecommunications (TMT). I'm Brooklyn born and bred, and I started college close enough to home so that I could come back home every weekend; my family is tight knit. After 2 years of that, I realized that the university I was attending was not going to take me where I needed to go as I was attracted to a more liberal arts curriculum than where I was and I moved to the DC area to complete my undergraduate degree at George Washington University in Philosophy of Communications. My plan at the time was to go back home to Brooklyn to get my law degree then set out on my way to saving the world one little mind at a time. And the summer before I was to set out to do just that – I got a temp job that sent me to assist two attorneys at a company called Ameritech. The two attorneys just happened to have worked at the FCC just a year and a few months before I temped for them and the experiences they shared with me were fascinating. Within a week of me starting – they offered me a full-time position as their paralegal / legal assistant. I never looked back, and I have no regrets.

Q: Tell us about the various places you've worked through the years and a little bit about what you are doing now.

A: I've been with AT&T for over 26 years. I held many positions prior to joining the company – but the resume rule is that you only show the last 10 years of your career so those jobs don't even show up on my resume anymore and were pretty basic early stuff. I have held responsibility and worked on many subject areas throughout my career at AT&T and I've done that from different corners of the DC area. I am an anomaly in that I have not relocated and have been in the AT&T DC office my entire career. My current areas of subject matter expertise where I support the business are a full range of universal service issues – never a dull moment there – and matters involving digital equity. A large part of what I do is collaboration and education outside the company; there is quite a bit of talking involved. I liaison with the FCC in my substantive areas, and in my Chief of Staff role I manage budgets and handle a range of people issues. So quite a lot to do but it keeps things interesting.

Q: Have things unfolded in your career more or less the way you planned?

A: My career has been so much more than I planned. I have been able to not only experience regulatory work and expand my knowledge exponentially - learning from some pretty smart people, I have been able to serve my community, network and travel to places in the capacity of looking like the communities that AT&T serves. I feel truly blessed as I have been supported by leaders at AT&T

who allowed me to blaze my own trail – both internally and externally – and fostered a space where I could and did excel. My mother realized this about me when I was very young – give her the project – give her the assignment – and she will get it done. She will find the tools and figure it out. I have had mentors who also saw those qualities in me and not only recognized it but cultivated it. And I flourish in those settings (I'm a true Capricorn)!

Q: What's the most interesting or challenging thing that you've done in your current position?

A: TMT is interesting and challenging at the same time. There is always something new to learn and I continue to experience new areas within TMT in my career. What keeps it interesting is that it is always changing.

I think the most challenging thing that I have done in my current position is navigate the conflicting changes – more recently – keeping the team (and myself) engaged during the uncertainty of COVID. When we were all sent home without an idea of what was happening next, I was challenged with ways to keep our team connected. I had to create some semblance of normalcy – while inevitably blurring the lines between personal and business. I mean folks were seeing the inside of my home on video calls who I wouldn't have ever invited to my home (no offense)! It was a challenging time for everyone. But we learned so much from that time about new ways to foster connections and to collaborate.

Q: Is or was there something interesting or someone who surprised or impressed you during your career and why?

A: I have had the good fortune of meeting all sorts of people throughout my career. I have attended conferences or events where I had the pleasure of meeting celebrities in the community from authors to CEOs of

non-profits. It's hard to single out one person as the most memorable – but I will say that one of the top 10 folks who left a long-lasting impression on me was Brenè Brown. She is as amazing a writer as she is a speaker. And it helped that I had read one of her pieces prior to meeting her. It felt like she was chit chatting on my living room couch when I saw her – it was as if she was just talking to me and exchanging ideas of how to navigate those common but difficult spaces in life with grace and empathy.

Another top 10 person was Judy Smith (the real-life Olivia Pope). OMG – what an experience – one that is etched in my memory bank in cement. It felt like she was in my kitchen while I cooked dinner for us and my family was family-ing ... and she did not bat an eyelash. So regular, so refreshing and so very insightful. To sum up - all of my experiences in meeting folks have been amazing and have shaped my approach to my career. Each one taught me something and stretched me.

Q: What do you enjoy reading?

A: I love a good novel on my coffee table and a good soul hug book on my bedside table. Currently “The Celebrants” by Steven Rowley is on my coffee table and “The Mamas” by Helena Andrews-Dyer is on my bedside table. In general, I love reading pieces that challenge my imagination while also enhancing my vocabulary.

Q: Is there something (a hobby or other tidbit) people don't know about you that you are willing to share?

A: Most folks who know me know that I love a good shopping day with a good brunch to kick it off and a good DJ to dance the night away. And most folks know that I am a Brooklyn girl with fifty million kids who likes to

have fun! Perhaps what folks don't know is that I come from a line and legacy of educators who, despite facing adversity and inequality in the education system for black folks, went to and graduated college coming out of serving in WWII. That proud legacy can also be seen in bricks and mortar as the Walter Weaver Elementary School in Brooklyn is named after my grandfather who was a teacher and also worked at the New York Board of Education.

Q: Can you share your perspective on the pitfalls to avoid or other career advice for those who are just getting started in the communications field?

A: One of the potential pitfalls to figure out managing through is recognizing and learning how to get out of your own way. Not only are you navigating people around you – you are also growing and learning about yourself and your capabilities throughout your career. Over-thinking has its place, but it should not lead to paralysis. When you face obstacles – especially as you are elevated in an organization – giving yourself some time and space to think through the best approach to a problem or anticipated issue is a good thing. What I am suggesting you avoid is overdoing the overthinking to the point that you are fearful to move. Notice when you begin to over think. Figure out what brings you clarity and helps to stop the cycle. And of course, know how to unstick yourself and keep moving.

Q: How has your life changed as a result of COVID-19 and what are you looking forward to doing next?

A: The depth of COVID times has to be one of the most memorable times I've experienced. We have seen many life-changing historical events (e.g. 9/11, first Black president), and this one was way up there. I tend to think that life has changed for the better from having to be resilient and to adapt to get through it. But the jury is still out on that as I realize over time

that I'm becoming detached from some of the habits that I formed during that time (reluctantly). I have to consciously enhance and build on the good habits that I developed, such as taking time to get some fresh air throughout the day.

Q: How long have you been an FCBA member, and what to you is the value of FCBA membership?

A: I have been volunteering for the FCBA for over 17 years. I was the AT&T representative at events but initially not as a member as membership in the association was limited to attorneys. When the FCBA changed that restriction, I immediately became a member, but I can't recall exactly when that happened. However, once I was able to join the FCBA, I quickly became part of a couple of committees or working groups - my perennial staples are the Charity Auction, the Annual Seminar and the Diversity Pipeline Program. I've stood for election and served on the FCBA Foundation and co-chaired it. The need for continuity with Foundation work even as people rotate on and off of the Foundation Board led me and my fellow co-chair to suggest a new co-chair framework for the Foundation. The Executive Committee endorsed that, and I am happy to say seems to work well. I also help on other committees – Women's Leadership and Wireline Committee – as needed. It has been a tremendous honor serving in the FCBA – there are so many opportunities to support the community at large and the membership. What I value most is the close-knit connection to my fellow FCBA members and the shared desire to serve. So, all you non-lawyers out there, I highly recommend you dive right in!

Kathleen Mary Harte Wallman (1957-2024)

Kathleen Wallman, Chief of the then-Common Carrier Bureau during 1994-95 and prior to that Deputy Chief of the Cable Services Bureau, died July 14 from appendiceal cancer. She was 66.

Wallman was president of Wallman Consulting, LLC, a telecommunications and technology policy consulting firm. She was also a Visiting Research Professor and an Adjunct Professor at the Graduate School of Arts & Sciences, Georgetown University.

Wallman was appointed by FCC Chairman William Kennard in 1999 to chair the Public Safety National Coordination Committee (“PSNCC”). Between stints at the FCC and her chairing of the PSNCC, i.e. during the period 1995-1997, she was Deputy Assistant to President Clinton for Economic Policy and Chief of Staff and Counselor to the National Economic Council, after serving as Deputy Counsel to the President in the Office of White House Counsel.

Wallman earned her J.D., *magna cum laude*, from Georgetown University Law

School in 1984, and a Masters degree with honors in the same year from the Walsh School of Foreign Service, Georgetown University. She graduated from Catholic University in 1979 with a bachelor’s degree, *summa cum laude*, where she was a member of Phi Beta Kappa and a number of other honor societies, receiving the President’s Award for overall academic achievement. She attended C.U. on a full, four year academic scholarship from the Archdiocese of Boston.

After law school, she clerked for Judge Laurence Silberman and Edward Tamm of the United States Court of Appeals for the District of Columbia Circuit, as well as Judge Pauline Newman of the United States Court of Appeals for the Federal Circuit. She then joined Arnold and Porter, becoming a partner with the firm before joining the FCC.

Wallman also co-founded and was a director of Folio Financial, Inc., a financial technology and securities brokerage firm which was acquired by Goldman Sachs in 2020.

She authored numerous scholarly publications on digital commerce and telecommunications policy and served on numerous boards of directors for both public and private companies and

foundations. Wallman also co-founded CANCollaborate, a 501(c)(3) organization devoted to accelerating treatments and cures for rare cancers.

Wallman was proud of being active in her high school concert, jazz and marching bands. She loved teaching, wrote a novel, *The Gossip Boats*, had numerous art projects, and became a Master Gardener growing a large garden’s worth of produce to share with others. She also played guitar, keyboard and cello and composed her own music. Her enthusiasm for life and her respect for her parents and heritage led her to learn Gaelic and earn dual Irish/US citizenship. If the above were not enough, she was also a recognized gourmet chef, a podcaster with two separate podcast series, a certified personal trainer, a distance runner, and an avid hiker and a weightlifter.

Kathy is remembered as a person of remarkable ability and accomplishments, but more importantly as a person with an open heart who was ready to provide a caring shoulder or serve as a trusted counselor, a person who brought out the best in those who knew her.

She is survived by her husband, Steven, her sister Margaret, and several nieces and nephews.
